Event Rules, Terms & Conditions of entry

- ❖ The exhibitor's entrance gate will be open from 7am on both Saturday and Sunday. The site is a large field near Froxfield and High Cross, opposite The Trooper Inn on the road that runs from Hedge Corner (A32) to Petersfield. Nearest post code GU32 1BD. What3Words <https://w3w.co/compose.drooling.equipment>. Exhibitors are required to be on site by 10.00am. The exhibitor's entrance gate will be shut at **10.30am** prompt. **For Health & Safety reasons, there will be no admittance for late arrivals and no "on the day" entries.**
- ❖ All drivers must be 16 years and over and hold an appropriate licence for the vehicle being driven and must be covered by the insurance required to comply with the Road Traffic Act 1991. **The carrying of passengers is strictly prohibited and under no circumstances can passengers ride on any equipment/trailer attached to the exhibit.** Driving Licence and current Insurance documents must be available for inspection at all times.
- ❖ All exhibitors are responsible for any equipment brought onto site, the Wessex historic tractor and implement club will not be held responsible for any damage or loss to merchandise, equipment or items not owned by the club.
- ❖ All exhibitors are responsible for the safety of their guests, children and any pets. All dogs must be kept on leads at all times and all dog fouling must be cleaned up and disposed of appropriately. WHTIC will not be held responsible for any loss of goods or damage howsoever caused to exhibits by a third party during the event.
- ❖ Camping pitches will be provided free of charge to Exhibitors on a first come first served basis and those camping for the weekend can access the site on Friday the 15th August from 10:00hrs to 20:00hrs when entrance will be shut. Fresh water is available on site and chemical waste disposal facility but no EHU. Disposable BBQs will not be permitted on site. Fire pits must be above the ground and not left unattended at all times and extinguished after use and taken home. Please ensure that all rubbish is disposed of appropriately and clear your area and adjoining areas each day after the event.
- ❖ Any instructions given by the site Marshalls must be followed and adhered to at all time.
- ❖ Non-compliance of any of these conditions will result in the Exhibitor being asked to leave the site immediately.
- ❖ Entry wristbands will be allocated at a ratio of 2 per named entry and must be worn at all times
- ❖ Traders pitch fees are done on a donation basis with a recommendation of 5-10% of takings. The event and club are run as a charitable organization with a large amount of profits being raised for the Hampshire and IOW air ambulance.
- ❖ Please advise the size required for your pitch, we will endeavor to accommodate all pitch sizes and will be notified in advance if this is not possible.
